With reference to your application on the subject cited above. I am directed to call for the approval of competent authority for grant of recognition of Victoria Public School, Brijpuri, Wazirabad Road, Delhi-94, from class I to X with effect from session 2005-2006 subject to the fulfilment of the following terms and conditions without aid.

1. That the school shall abide by the provisions of Delhi School Education Act, 1947 and Rules framed there under as well as the instructions issued from time to time by the Department.
2. That the school shall admit students without any discrimination of caste and creed.
3. That the school shall meet the additional liability of Secondary classes along with additional class rooms for class IX and X.

That the school shall purchase adequate science lab equipment and apparatus as per the norms of C.B.S.E. Education Department for Secondary Classes.

That a proper library shall be established and facilities for reading room shall also be made available for students as well as for teachers. Books as per the ratio of one book per student shall be purchased and made available to the students.

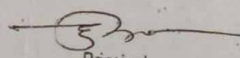

6. That the adequate sports material shall be purchased and made available to students.
 7. That the school shall abide by the provisions of section 10 1 (1) (A) of the De School Education Act. Rules, 1973.
 8. That the school shall not run unrecognized classes or any non-educational activity within the school premises. Nursery classes be removed from the premises of school immediately, if any.
 9. That the school shall dispense with the services of unqualified and over aged staff any immediately.
 10. Fresh Health certificates from the MCD be obtained and produced to Education Office for verification.
 11. The management of school will obtain land from DDA, if already not obtained, in name of the society through Director of Education, Delhi and shall construct the school thereon the school as per specification of the Department within a period of 5 years. That adequate and sufficient accommodation of 10 sq. ft. per student shall provide the class room and shall be not less than 300 sq. ft. area.
 12. That a proper facilities for drinking for drinking water, toilets and first aid be provided separate toilets for boys, girls and separate toilets for ladies and gents staff be provided.
 13. That the Managing Committee of school shall not increase/enhance fee during ensuring academic session without prior approval of the Director of Education which is mandatory requirement under subsection (3) of section 17 of Delhi School Education Act & Rules, 1973.
 14. That the school authority will apply for P.F. facilities to the provident commission and will provide the same to the staff in proper manner.
- That all the facilities prescribed under Rules 50 & 51 of Delhi Education Rules, 1973 shall be made available to the students.

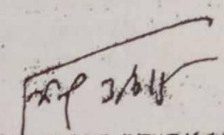

16. That the Management of the school shall create reserve fund equal to Rs. 2 lacs plus Rs. 80/- per student in the joint name of the Dy. Director of Education and the Manager of School.
17. That the school shall comply with the norms of the C.B.S.E. for affiliation for Examination purpose.
18. The school will apply for nominee of DE/Advisory Board to the Act Branch of Dte. Education.
19. The school should provide PF, LTC Medical facilities to the staff as per DSER.
20. That report about the fulfillments of the above conditions shall be sent to the Education Officer within six months.
21. That school authorities will take steps to disinfect the water so as to make it fit for drinking purpose.

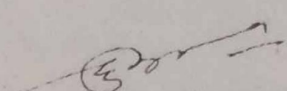

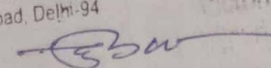
